# **Brief History of ORANJ**

By the late 1980's, fourteen Continuing Care Retirement Communities (CCRCs), offering facilities for the three stages of *Independent Living, Assisted Living, and Long Term Care* had been certified for senior citizens in New Jersey. Nine of these had only recently opened their doors. Newly formed Resident Associations were facing problems for which there was no prior experience. They began to reach out to each other for help. In 1991 the presidents of the fourteen Associations met at Applewood Estates in Freehold and officially founded the Organization of Residents Associations of New Jersey (ORANJ).

Residents Associations in twenty-five of the twenty-six CCRCs presently certified for occupancy in New Jersey are members of ORANJ. Over 10,000 seniors are currently in residence.

Soon after the organization of ORANJ, its leaders reached out to help in the formation of the National Continuing Care Residents Association (NaCCRA), founded in 1992.

Although the Mission Statement and Goals of ORANJ have grown over the years, the central purpose remains working cooperatively for the well being of senior citizens. Across the state, issues and challenges faced are similar. In working together, senior citizens multiply insight, strength and influence for change and improvement.

## How ORANJ Works

The State of NJ is divided into 5 **regions** each with its own Vice-President (VP). Each VP conducts quarterly regional meetings for the CCRCs in his/her region where issues are discussed in small groups.

Much valuable work of ORANJ is done through its **Standing Committees** in the program areas of Communications, Finance, Health Care, and Legislative Action and Advocacy.

A newsletter, *The ORANJ TREE*, is published quarterly. The Executive Committee carries out recommendations from the standing committees and the Vice Presidents and is responsible for long range planning which is reported at the plenary meetings.

A highlight of the ORANJ year is the **plenary meeting** held each spring and fall when delegates meet in different CCRCs to hear reports, determine policy matters, and set program priorities. Outside experts are invited to speak. These meetings also provide opportunities for members to get to know one another in their home settings.
