Detective Jasina is a Field Training Officer, handgun instructor, and rifle instructor, and assists with the training of county law enforcement officers in active-shooter response.

**Detective Anthony England** is a Detective employed by the Bernards Township Police Department and currently assigned to the Detective Bureau. He has over nine years of Law Enforcement experience. Prior to his employment with the Bernards Township Police Department, he attended Kean University and received a bachelor's degree in Criminal Justice with a minor in Public Administration from Kean University. He also attended Seton Hall University and received a Master of Arts in Human Resources Training and Development. He started his career in the patrol division and became a field training

officer, where he was responsible for training newly hired officers. In September 2019, he was assigned as a Task Force Officer and Detective with the New Jersey State Police, Motor Vehicle Crimes North Unit – Auto Theft Task Force, for over two years. There, he was involved in the arrests of numerous individuals involved in auto theft, carjacking, robbery, fencing, fraud, and in the recovery of numerous stolen motor vehicles. In June 2022, he was assigned to the Detective Bureau as a Detective and has attended multiple law enforcement schools and training courses.

Inspector Joseph Kaecker works for the United States Postal Inspection Service.
